WAIVER OF LIABILITY, ASSUMPTION OF RISK, & INDEMNITY AGREEMENT

In consideration for myself, my child or ward ("Releasors") being permitted to use the facilities or participate in any activity at Bounce Jungle, LLC, doing business as Bounce Jungle, for myself, my child and or my ward and on behalf of my or their heirs, assigns, personal representatives and next of kin:

1: a). I agree to follow the safety instructions stated or posted and acknowledge that failure to do so may result in expulsion from Bounce Jungle. b). I acknowledge and understand that there are known and unknown dangers and risks associated with the activities at Bounce Jungle which may result in personal injury, including the potential for paralysis and death, c). I voluntarily consent to participate in the activities and d). I hereby accept and assume all such risks, known and unknown, and assume all responsibility for the losses, costs and/or damages following such injury, disability, paralysis or death, even if caused, in whole or in part, by the negligence of the Releasees named below.

2: I agree to fully and forever waive, indemnify and hold harmless, release and discharge Bounce Jungle, LLC, its affiliates and all of its respective officers, trustees, employees, agents, successors and assigns (collectively "Releasees"), from any and all claims, damages, demands, rights of action or causes of action, present or future, known or unknown, anticipated or unanticipated, resulting from or arising out of attendance at or use of the Bounce Jungle Facilities or Bounce Jungle activities, whether related to use of the inflatable amusement devices or not. Further, Releasor hereby waives any and all such claims, damages, demands, rights of action or causes of action, for any injury, including, but not limited to personal, bodily, or mental injury, economic loss or any damage to releasor, releasor's spouse, guest, unborn child or relative. In addition, Releasor hereby agrees to release and forever discharge the Releasees from any and all liability for any loss or theft, or damages to personal property. Releasor acknowledges that he/she has carefully read this Waiver and Release and fully understands that it is a waiver and release of any and all liability.

3: I agree that if, despite this release, I, my child or ward, or anyone on either's behalf, makes a claim against any of the Releasees, I AGREE TO INDEMNIFY, DEFEND, SAVE AND HOLD HARMLESS THE RELEASEES and each of them from ANY LITIGATION EXPENSES, ATTORNEY FEES, LOSS, LIABILITY, DAMAGE, OR COST THEY MAY INCUR DUE TO THE CLAIM MADE AGAINST ANY OF THE RELEASEES NAMED ABOVE, WHETHER THE CLAIM IS BASED ON THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE.

4: The undersigned acknowledges that this release and waiver of liability form will be used and relied upon by Bounce Jungle LLC and that it will govern the undersigned's actions and rights.

5: I have read this consent, release and waiver of liability, assumption of risk, and indemnity agreement, and understand that by signing it I give up substantial rights I and/or the minor or ward would otherwise have to recover damages for losses occasioned by the releasees' fault, and sign it voluntarily and without inducement.
